Pro-Novice & Nursery - 175 yd. outrun, drive, cross drive, pen

PRO-NOVICE Handler's meeting - 8:00 am, followed by NURSERY & NOVICE

Awards: Daily cash pay-out to 5 places in each class

Rosettes to 3rd place for aggregate score over the two days in each class
